Greene County officials revealed that Hamvention will be held at the Greene County Fairgrounds next year, according to our partners at the Xenia Gazette. "

We have been seeing this happening to a lot of hamfests the past few years, even our own. Many are now holding tailgate events instead of the full hamfest because of costs and locational changes and because the setup is easier.

Even though PARC had postponed the 2016 Portage hamfest we will continue with our new location and same date in July next year 2017.

It is with deep regret we report the passing of 2 former Portage Amateur Radio Club members and friends.

Bob Charles Bassett, KE8UV, 67 went to the big radio station in the sky after a battle with cancer. Bob was an involved radio amateur who worked with the Cleveland Red Cross and other organizations. He also enjoyed rail roading and volunteered with the Cuyahoga Valley Railroad. Best known as a radio personality in the Northeast Ohio area Bob was a disc jockey at many local stations. Interestingly, Bob's involvement in radio and TV dates back to the days of Ernie Anderson (Goulardi) at channel 8 where Tim (Tom) Conway, Big Chuck and Hoolihan and many others worked. Bob worked at the Portage Hamfair getting the word out on WSTB in Streetsboro where he would do spots from the Hamfair that were broadcast live over the radio. His involvement and dedication in the area lasted almost to the end. He will be missed by many but has left a legacy that will live on.

Norman Jennings, W8BBN, 82 of Kent, a past member of our club also passed. Norm was born in Portage County attending Ravenna Township high school and Kent State University. He spent time in the army and worked in the space program at Cape Canaveral, Florida with Goodyear Areospace. Changing careers got into real estate and he and his wife of 62 years, Betty, NN8F, ran bjennings realty in Kent for many years.

Bob and Norm will both be missed. Over the years we have lost many of our friends and fellow hams. While their passing always leaves a hole that can never be filled the important thing is the legacy that they leave for us.

Dayton <u>Hamvention</u>® is moving on after 52 years at Hara Arena, and 2017 preparations at the show's new venue in Xenia, Ohio, now are in full swing, two Hamvention officials <u>explained</u> this week on the <u>Amateur Radio Roundtable</u> webcast hosted by Tom Medlin, W5KUB. Hamvention announced on August 1 that it would relocate to the <u>Greene County Fairgounds</u>, after Hara Arena made it known that it would close at month's end. Hamvention 2017 General Chair Ron Cramer, KD8ENJ, and official spokesperson Mike Kalter, W8CI, fielded questions from Medlin and callers during the hour-long August 9 show. Cramer said some members of the Amateur Radio community entertain preconceived notions about the new venue that are "far off base," and he and Kalter wanted to set the record straight.

"Change is hard for everyone, but I think this is a very good move for us," Cramer said. "You will be very impressed." Kalter echoed the sentiment. "We want to start out great and get awesome," he said. Kalter said there's been a lot of second-guessing, but that "a lot of overriding factors" and year-long search led to the selection of Greene County Fairgrounds.

Kalter assured those planning to attend Hamvention that Fairgrounds buildings — particularly those used for showing livestock during the county fair — are "absolutely clean" and well maintained (see attached layout map). He and Cramer expressed confidence that everyone will find plenty of available parking and room for all traditional Hamvention activities — more than may be evident at first glance. Vendors who have already visited the new site to get the lay of the land went away "excited," they said.

At this point, no hard-and-fast decisions have been made as to how Hamvention will put the available buildings and space to use next spring, but Cramer and Kalter said the Fairgrounds staff has been especially helpful. "We're all working together now to make this happen," Kalter said, and that Hamvention officials remain open to questions and suggestions.

Cramer took time to quash one misconception about Hara Arena. "Even though they had air conditioning," he said, "air conditioning was never used there. The doors were open, and they did not want to turn on the air conditioning unless the doors were closed. So, I don't think air conditioning was used at all — at least in the last 10 years."

Some air conditioned space already available at the new venue may be suitable for such activities as forums, and the Fairgrounds is looking to upgrade existing ventilation systems in non-air conditioned buildings. "We're looking at the possibility of air conditioned 'chalets'" for forums, Kalter said.

The prime area under consideration for the popular outdoor flea market is inside the racetrack oval, they said, and additional adjacent space is available, if it's needed.

The venue will have wireless Internet coverage. "We've already moved some of the equipment out of Hara, and we think it will do a good job there," Cramer said. Kalter added that the Fairgrounds staff is working on upgrading the Internet "pipe" to the venue.

As for the admission price, "We're still working on that," Kalter said. "We have not made a decision. We may leave it at the same price or slightly more than that, but no great increase." Tickets this year were \$20 in advance and \$25 at the gate for all 3 days.

Cramer and Kalter said Hamvention anticipates being ready to start selling tickets and vendor spaces by November — and perhaps earlier.

Kalter stressed that the sponsoring Dayton Amateur Radio Association (<u>DARA</u>) puts "an awful lot back into ham radio in donations," all raised entirely through Hamvention.

"We need your help. We need your support," Kalter said. "Hamvention needs to move on, and we intend to make it happen, with everybody's help.

How to Obtain an Official FCC License Copy

The FCC went paperless in February 2015. In order to streamline procedures and save money, the FCC stopped routinely printing and mailing licenses.

There are a number of ways a license holder can obtain an official copy of their license. The official license will display the FCC logo and the watermark "Official Copy" will be printed across each page of an official authorization from FCC.

- 1. Download and Print License: The licensee can log into the FCC ULS License Manager System http://wireless.fcc.gov/uls/ with their FRN and password to 'Download the Electronic Authorization' of the official license. On the 'Download Authorizations' page the license holder will <u>add</u> their call sign to the 'Authorizations to Download' and then click download. The PDF of the license can be saved to a computer and printed later or the file can be opened and printed immediately.
- 2. Login and Set Paper Preferences: The licensee can log into the FCC ULS License Manager System http://wireless.fcc.gov/uls/ with their FRN and password and choose 'Set Paper Authorization Preferences'. This option determines whether a user will receive paper authorizations (printed license and FRN information) from the FCC for future mailings.

On the 'Set Paper Authorization Preferences' page, the license holder would select either YES or NO and then click SAVE. By selecting YES, you will continue to receive paper authorizations printed and mailed by the FCC. By selecting NO, you will not receive authorizations printed and mailed from the FCC. This preference will affect all granted authorizations on this FRN.

3. Receive License via Email: When modifying, renewing or requesting a duplicate copy of the license, a licensee who already has an FCC Registration Number (FRN) and provides a valid e-mail address under "Applicant Information" while logged in to the ULS system will receive an official ULS-generated electronic authorization via e-mail.

The action of adding a valid e-mail address into the FCC system can also be performed by a VEC filing new, upgraded, modified or renewed licenses on behalf of applicants. All exam applicants should include a valid email address on their NCVEC 605 form, in order to receive their license electronically.

4. Contact FCC: Licensees may also contact FCC Support via the web, telephone or mail to request paper licenses.
Please note that FCC stopped using distinctive paper stock to produce hard copy licenses and has been printing these on "standard, white recycled paper." The Bureau noted that the distinctive paper stock it had used was six times more expensive than the plain recycled paper it now uses.

An unofficial "reference copy" can always be printed from the FCC's ULS License database http://wireless.fcc.gov/uls/. Licensees can also find these instructions on ARRL's Obtain a License Copy web page www.arrl.org/obtain-license-copy.

Grandma's Apothecary





Jewelweed is another amazing plant also known as touch-me-nots because when you touch a ripe seed pod it will pop and spread seeds everywhere. If you cup your hands around the ripe seed pods and grab tightly the seeds will pop in your hand and can be eaten. They taste like walnuts to me. Jewelweed is a popular remedy for poison ivy. Breaking the stems and rubbing the juice on the affected area will usually prevent the rash from forming. If you already have the rash you can still use the juice to help dry it out and heal. Virtually any type of skin irritation including acne and bug bites can benefit from jewelweed. This little wonder is also an anti-inflammatory and anti-fungal. In fact, it happens to be the main ingredient in Preparation H!

To make jewelweed salve simmer about a handful of jewelweed in about a quart of sesame oil (or any light vegetable oil except olive oil, which burns) for 10-15 minutes. Strain out the herb, add a handful of beeswax to thicken it, and heat until melted. Take out a spoonful and let it cool to test the thickness, and add more oil or beeswax as needed. Add the contents of one oil-soluble vitamin E capsule, a natural preservative, and let it cool. Keep refrigerated and this will last for about 4-6 months.
